## Programme of Work Conferência of General Review Conference of the United Nations Charter

### Secretariat Notes

#### Agenda Allocation

1. The agenda items assigned by the General Assembly to the General Review Conference of the United Nations Charter are listed in the First Report of the General Committee to the FAMUN General Assembly (A(FAMUN)/12/251).

#### Programme of Work

2. The draft programme of work (see annex) was prepared considering the Provisional Agenda of the Twelfth Regular Session of the FAMUN General Assembly (A(FAMUN)/12/151) and the availability of documentation.

#### Speech Time Limits

3. The General Review Conference recommends following the guideline suggested by the FAMUN General Committee to the General Assembly in its first report (A(FAMUN)/12/251), setting a limit of 2 minutes per Member State during the general debate. In this regard, the Conference encourages Chairs to fully exercise their responsibilities as defined in Rule 13 of the Rules of Procedure.

#### Conference Services and Meeting Arrangements

4. Considering the availability of conference services, seven meetings are scheduled: September 4: 16:30–18:30; September 5: 09:00–11:00, 11:30–13:00, 15:00–17:00; September 6: 09:00–11:00, 11:30–13:00, 15:00–17:00; September 7: 09:30–11:00. The General Review Conference reminds delegations that punctuality is essential to ensure effective organization of work at FAMUN.

### **Informal Consultations**

5. The Conference will use the first and second informal meetings for regional group discussions. These and subsequent informal meetings are intended to help reach consensus on a draft resolution where possible.
6. The *Bureau* may act as or appoint facilitators to assist in the consensus-building process.
7. Informal meetings can be chaired by members of the *Bureau*, facilitators, or other delegates. As per established practice, informal consultations are used to share general observations on proposals and adopt them *ad referendum*. All drafting of resolutions will occur in informal consultations.

### **Conclusion of the Conference's Work**

8. Given the number of meetings scheduled, the deadline for concluding the work of the General Review Conference is set for September 6, 2025, at 17:00, so that final action on all draft resolutions can occur at the FAMUN 2025 Closing Plenary at 09:00 on September 7, 2025.
